**ORDER**

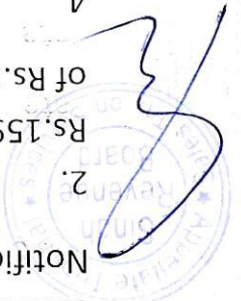
**Intiaz Ahmad Barakzai:** The representative of the appellant sent application for withdrawal of appeal stating therein that the appellant had availed the Amnesty Scheme of 2020, and had paid Rs.15,978/= being 10% of the default surcharge of Rs.159,780/= in pursuant to the Sindh Revenue Board's Notification No. SRB-3-4/11/20209 dated Jun1, 2020.

2. This appeal was filed against the imposition of default surcharge of Rs.159,780/=. The appellant has produced the copy of CPR showing payment of Rs.15,978/= on 11.06.2020 under the Amnesty Scheme 2020.

4. Ms. Uzma Ghory, AC-DR, SRB submitted that the principal amount of tax of Rs. 143,511/= was duly paid by the appellant during the pendency of appeal before the Commissioner (Appeals) and the penalty of Rs.232,149/= was

remitted by Commissioner (Appeals). However, only the default surcharge was payable and since the same has been duly paid the department has no objection for withdrawal of appeal.

5. Since all the amounts levied in view of the Order-in-Original (OIO) and Order-in-Appeal (OIA) have been duly paid and nothing needs to be determined by the Tribunal the appeal is disposed of as withdrawn.
