ORDER

Justice[®] Nadeem Azhar Siddiqi: This appeal has been filed by the appellant challenging the Order-in-Appeal (hereinafter referred to as the OIA) No.26/2021 dated 02.04.2021 passed by the Commissioner (Appeals) in Appeal NO. 135/2019 confirming the Order-in-Original (hereinafter referred to as the OIO) No. 120/2019 dated 19.02.2019 passed by the Deputy Commissioner (Mr. Syed Rizwan Ali), SRB, Karachi.

In the instant matter the OIO was passed determining the Sindh Sales Tax (SST) of Rs.1,007,826/= against the service provided by the appellant under Tariff Heading 9809.0000 (contractual execution of work or furnishing supplies) of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as the Act) during the Tax Period November-2017 alongwith payment of default surcharge and penalties.

03. The appellant challenged the said OIO before Commissioner (Appeals) by way of filing of appeal. However, during the pendency of



appeal the appellant deposited SST amounting to Rs. 1,007,826/=. The Commissioner (Appeals) ordered for payment of default surcharge of Rs.346,329/= under section 44 of the Act and penalties of Rs.150,391/= under Serial No. 3 and 15 of the Table under section 43 of the Act.


04. The appellant had challenged the said OIA imposing default surcharge and penalties before this Tribunal.

05. After filing of the appeal the learned advocate for the appellant filed application dated 23.06.2021 and submitted that the appellant has availed Amnesty-2021 and discharged its liability and requested to allow withdrawal of appeal.

06. In view of the above, since the purpose of filing of appeal borne fruit the appellant is allowed to withdraw the appeal.

06. In view of the above the appeal is disposed of as withdrawn. The copy of this order may be provided to the learned representatives of the parties.
