ORDER

Justice ° Nadeem Azhar Siddiqi: This appeal has been filed by the appellant challenging the Order-in-Appeal (hereinafter referred to as the OIA) No. 76/2021 dated 17.12.2021 passed by the Commissioner (Appeals) in Appeal No. 19/2021 filed by the Appellant against the Order-in-Original (hereinafter referred to as the OIO) No. 45/2021 dated 18.02.2021 passed by the Mr. Waleed Patoli, Assistant Commissioner, (Unit-34) SRB Hyderabad.

02. The appeal was filed on 25.02.2022 and was fixed for 10.03.2022 and 28.03.2022 but the representative of the appellant did not appear on due date and
