ORDER

Justice Nadeem Azhar Siddiqi: This appeal was filed by the appellant challenging the Order-in-Original (hereinafter referred to as the OIO) No. 287/2019 dated 15.04.2019 passed by Mr. Zuhair Muhammad, Assistant Commissioner, (Unit-24-Withholding) SRB Karachi has been transferred to the Tribunal under section 57(9) of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as the Act).

02. None present for the appellant despite service of notice for today's date through courier on the Secretary Education and Literacy Department, Government of Sindh. Same was the position on the last date i.e. 09.06.2022. Since the
