ORDER

Justice Nadeem Azhar Siddiqi: This appeal has been filed by the appellant challenging the Order-in-Appeal (hereinafter referred to as the OIA) No. 33/2022 dated 05.04.2022 passed by the Commissioner (Appeals) in Appeal No. Nil/2021 filed by the Appellant against the Order-in-Original (hereinafter referred to as the OIO) No. 285/2019 dated 15.04.2019 passed by Mr. Muhammad Siddique Soomro, Assistant Commissioner, SRB Sukkur.

02. The appeal was filed on 26.05.2022. The office raised the following objections:-

- i. Deposit Appeal Fees in the Account of the Appellate Tribunal.
- ii. Provide the copy of Show Cause Notice (SCN).
- iii. Two more sets of appeal, one fore Member Technical and other for the Department.

The appellant was directed to made compliance within seven days and case was adjourned to 13.06.2022.

03. On the next date i.e. 13.06.2022 no one was present for appellant. On 20.08.2022 the advocate for appellant sent adjournment application. Same was the position on 29.08.2022.

04. The appellant deposited appeal fees and submitted copy of challan on 30.08.2022.

05. The advocate for the appellant obtained adjournments on 19.09.2022, 10.10.2022 and 02.11.2022.

06. On the last dated i.e. 02.11.2022 the adjournment was granted as a last chance with the following observation.

“In case the compliance is not made before the next date and advocate for the appellant fails to appear on the next date the appeal would be dismissed for non-prosecution.”

07. Today the advocate for the appellant is again absent and send adjournment application. Apparently, the appellant and his advocate has no interest in proceeding with this appeal on merit.

08. In view of the above the adjournment application is rejected. Consequently the appeal is dismissed for non-prosecution. Copy of the order to be supplied to the parties.
