ORDER

 Justice Nadeem Azhar Siddiqi: This appeal was filed by appellant before the Commissioner (Appeals-II), SRB under section 57(1) of Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as the Act) challenging the Order-in-Original (hereinafter referred to as the OIO) No 233 of 2017 dated 22nd August, 2017 passed by Mr. Yousuf Bukhari, Assistant Commissioner, (Unit-30), SRB Karachi, and has been transferred to the Tribunal under section 59 (7) of the Act for treating the same as an appeal against the order of Commissioner (Appeals-I) for disposal in accordance with law.
